- 2. Contest is open only to legal U.S. residents who are age 18 or older residing in the Atlanta, GA; Abilene, TX; Amarillo, TX; Brunswick, GA; Charleston, SC; Ft. A bill must be a photo copy or scan of the original bill. No original bills will be accepted. The account number on the bill MUST be blocked out or covered; bills reflecting an account number will not be accepted. Entrants must include their name, date of birth, and daytime phone number on the bill. All bills must be received no later than Wednesday, January 28, 2015 at 11:59:59pm EDT.

Entrants may submit as many individual bills as they like. Each individual bill may only be submitted once. Multiple entries of the same bill will be disqualified.

6. The Bert Show will conduct the Pay Your Bills contest Monday through Friday from January 5, 2014 through January 30, 2014. Each day at approximately 5:35am EDT/4:35am CDT, 6:35am EDT/5:35am CDT, 7:35am EDT/6:35am CDT, 8:35am EDT/7:35am CDT, and 4: 35pm EDT the on-air personality will announce one (1) name of entrants randomly chosen from all eligible entries. The entrant name announced, as determined by the Station, will be declared the daily winner. No alternate winner will be chosen. All decisions of the Station regarding selection of entrants and winners are final and cannot be challenged. In the unlikely event that no candidate is found to meet the eligibility requirements, then the Daily Prize for that day will go un-awarded. In the event of a tie, the winner will be determined by and at the Stations' sole discretion
